- Only reservation or cancellation requests made during opening hours will be answered immediately.
- All requests must be confirmed by studio staff.
- Studios may be reserved a maximum of two weeks in advance.
- Studios are rented for a minimum of one hour and must be vacated at the exact end time of the reservation. If not vacated on time, users may be charged for the following hour. A minimum of one hour is required between two consecutive bookings.
- 24 hours' notice is required for all cancellations, taking into account of the welcome desk opening hours. If this is not respected, the user will be charged the full booking fee.
- In case of absence, we reserve the right to make the studio available for others after the first hour of reservation

GENERAL TERMS OF USE

Occupants agree to use studio spaces made available in accordance with the law and normal good practice. Acoustic studios are reserved for acoustic rehearsals only.

The studios may not be used for any commercial activity or teaching.

The Cité Internationale reserves the right to exclude any person who refuses to comply with these rules.

MAISON DES PROVINCES DE FRANCE STUDIOS (MPF)

Residents of the Cité internationale will benefit from preferential rates.

Open on weekdays from 10 am to 7 pm.

⚠ : reserved for users with a package, **for solo acoustic rehearsals only**. The access card must be withdrawn from the main reception in exchange of an ID.

MAISON DU CAMBODGE STUDIOS

Residents will benefit from the same rates as at the Maison des Provinces de France.

Open Tuesday to Friday from 10 am to 11 pm, Saturday and Sunday from 10 am to 8 pm.

⚠ : weekends between 10 am and 2 pm are reserved for users with a package or who have paid in advance. There is no administrative office, therefore registration and bookings are not possible.

2023-2024 RATES AND TERMS OF PAYMENT

Payment required on the day of the reservation or in advance. We accept cash, cheque and card payments.

Payments are not refundable.

Packages are to be used by the named holder only and remain valid for 12 months from the date of purchase.

Package 15h or 30h	22,5€ / 45€ (1,5€/h)

STUDIOS WITH OR WITHOUT PIANO (STUDIOS CAMBODGE 1, 2, 3, 4, 5)

GROUP RATES (3-4 pers)	
Hourly rate	12€/h
Package 15h or 30h	120€ / 240€ (8€/h)

ÉTAT DES LIEUX

The studio made available shall be deemed to be in good condition, unless the occupant reports otherwise at the start of each session of use.

Please note that rehearsal spaces are rented to other musicians when not used by the occupant. Occupants are, therefore, asked to report any damage or problem with the rehearsal room immediately upon entering. If this is not done, the occupant will be deemed responsible for any damage found by the following group.

Rooms must be kept clean and tidy. Please remember that smoking is strictly prohibited anywhere in the building, and eating and drinking are prohibited in the rehearsal rooms. The lobby is provided for this purpose. Please leave the lobby clean.

LIABILITY AND INSURANCE

Occupants will be responsible for any harm or damage to the Cité Internationale or third parties, resulting from their activity, their equipment, members of their group or any other person for whom they are responsible.

Occupants shall repair any damage they cause without delay.

If leaving the premises and leaving belongings inside, occupants commit to personally ensuring that premises made available to them are securely locked.


If occupants are not able to ensure that premises are locked, they must not leave any equipment, object or clothing unattended. The Cité Internationale shall not be responsible for any object or equipment left unattended on its premises that it makes available to users.

Occupants certify that they have taken out insurance to cover the risks mentioned above and damage to their own equipment.

The loss or theft of an access card has to be reported as soon as possible to the welcome desk to prevent any abuse by another person. In the event of a failure to return the card, you will be charged 10€ for its replacement.

FORCE MAJEURE

If it is impossible to use the spaces made available for a reason that is not attributable to any of the parties (such as act of war, riot, flood, fire, explosion, epidemic, etc.), reservations will be cancelled as of right and no compensation may be claimed by either party.
